SNOW REMOVAL CONTRACT

STORM SERVICE AGREEMENT

This upgrade will make your address into a priority account, and will set your address into one of the 10 reserved spots at the top of each trucks list. For the most part, priority accounts are all plowed within the first hour after the snowfall trigger has been reached. This upgrade comes at a cost of +25% the season quote above.

Shoveling Sidewalks - Would you like sidewalk shoveling service? Yes No

This additional service for the season is a flat rate of \$4/ft. of normal 3ft. wide sidewalk to be cleared. Every time we plow, we will get out of the truck and clear the walkways. With a minimum of \$50.

For example, 20ft of sidewalk clearing for the entire season would be \$60. (20ft x \$4 = \$80)

ReNew Services Customer Service Agreement

Scope of Snow Plowing: ReNew Services will plow when Snow Trigger Depth has been reached. This is measured by the contractor at the pavement, not to include drifts. Depending on the time of the snowfall, we attempt to service customers by 6:00 AM or 4:00 PM. Often times when plowing roads, the town will fill the driveways aprons with excess snow after driveways have already been cleared. If this causes a hazard or inconvenience, kindly contact us and we will attempt to clear this within a reasonably agreed upon time frame.

Turf Repair: In the event that the contractor damages any turf by snow plowing, the contractor will re-seed the damaged turf in the spring season during the snow and ice maintenance program season in which the turf damage occurred.

Disclaimer: ReNew Services will not plow or sand / salt within 2 feet from any parked vehicles, equipment, obstructions in parking lots, or other areas being cleared. ReNew Services is not liable for damage to pavement or other surfaces contracted for plowing of snow. Damage can occur, but we will make every effort to avoid this. Depressed areas in pavement may accumulate snow that may not be able to be removed, as well as snow that has been packed down by vehicle or foot traffic. ReNew Services is not responsible for these accumulations that cannot be removed but will do our best to remove them.

Indemnification: Owners shall indemnify, defend and hold harmless the contractor, its owners, and employees from and against any and all claims, damages, reasonable attorney fees, costs and expenses which the contractor incurs as a result of a claim or claims brought by the owner or any third party arising from any Act of God, including but not limited to extraordinary weather conditions, that is related, in any manner whatsoever, to the premises or the owners involvement with the premises or the services, including but not limited to personal injuries resulting from slip and fall accidents.

Life of Agreement: This agreement is valid from the date it is signed until April 1, 2020

Boundary Markers: Contractor will supply & install any markers needed.

Hazards: Customer is aware that plowing may not clear their property to bare pavement and that slippery conditions may and most likely prevail even after plowing and de-icing. ReNew Services assumes no responsibility for slip and fall accidents or vehicular accidents as a result of this naturally occurring condition.

For Per Seasonal Agreements: Payment is due at time of signing unless other arrangements have been made.
